#### Why Hotels Say NO to Business

Everyone had the opportunity to discuss and learn what hotels are looking for when receiving an RFP from a planner. The biggest factors are; dates, flexibility and knowing the off and peak season of the hotel(s) that are being considered. The suppliers were able to share a lot of great information such as that the hotel has a budget to achieve just like the planner has a budget to stay within. Certain items do not have a cost to the hotel such as upgrades. These items are more likely to be granted on a concession list.

The planners were able to share that their room rate budget of \$99 has not gone up in years. We were also able to learn that even within one government organization, each division may have a different budget that may allow them to pay more than the \$99 room rate.

The discussion was great and we were all able to learn a lot. A better understanding of each side of contract negotiations with the hotels was achieved.
