## "25 Tips for Personal Safety"

**Presenter: Allen Stucks, Executive Director, Big Bend Crime Stoppers**

**Meeting Review by H. A. Scott, CMP**

Allen Stucks, Executive Director of Big Bend Crime Stoppers presented the program at the Jan. meeting, sponsored by Kissimmee CVB and held at the Park Place Hotel. Allen's presentation focused on safety tips to be aware of while at a conference or while at home. He highlighted safety tips and identity theft prevention strategies and provided a number of great handouts and advice to the membership.

Among the many safety tips mentioned were: do not give your telephone number to a wrong telephone number caller; have your door key in hand when approaching your home entryway (or hotel room); never go into your home if something seems out of the ordinary; do not leave valuables in plain site within your vehicle; always carry a flashlight in your vehicle; when at work, lock valuables in your desk or other secure place; do not apply make-up, read, or text message on your cell phone while driving; be careful of leaving mail with identifying information in your mailbox; always ask for your receipt at restaurants and shops; do not combine other keys with your vehicle key (especially when using Valet parking services); above all: BE ALERT!!

Allen also provided time for attendees to ask questions and share safety tips of their own. Everyone benefited from this informative and helpful presentation while enjoying a variety of refreshments provided by our sponsors!



## Food for Thought

### Hummus

- 16 oz. can garbanzo beans
- Fresh squeezed juice of 1 lemon
- 2 garlic cloves, minced
- 1 tblsp. Tahini (a sesame seed paste available in most grocery stores or Asian markets)
- Salt and white pepper to taste
- 1 roasted red pepper
- 10 kalamata olives
- 2 slices pita bread
- Olive oil



Drain and puree the garbanzo beans. Add the lemon juice, garlic and tahini. Mix well and season with salt and white pepper. Dice half the red pepper and puree the other half. Drain and finely dice olives. Blend well with garbanzo mixture. Brush pita bread with olive oil and grill or toast until lightly brown on top. Slice into sections and serve with hummus. Can also be served with tortilla chips or as a dip for crudités.
